The Florida Department of Transportation (FDOT), District Six, is conducting a Re-evaluation of major design changes which encompass SR 826/Palmetto Expressway from NW 27th Avenue to the Golden Glades Interchange, and I-95 from SR 916/NW 135 Street/Opa-Locka Boulevard to Florida's Turnpike Spur in Miami-Dade County.

## **PROJECT OVERVIEW**

The project will focus on safety and operational improvements to accommodate the anticipated transportation demand, improve connectivity for traffic destined to the northbound I-95 Express Lane Connector to Florida's Turnpike, and improve mobility and multimodal use for both local and regional travelers.

## **PROJECT DETAILS**

- Safety and operational improvements to the northbound I-95 Express Lane near the GGI by removing the egress located at NW 151st Street and rerouting certain movements
- Providing a direct connection via the northbound (NB) Express Lane Connector from the northbound I-95 Express Lane directly to Florida's Turnpike Spur
- The relocation of the planned access points for the Palmetto Express Lanes to a point near NW 27th Avenue

## **PROJECT DATES**

This Re-evaluation is anticipated to be completed in May 2018. Construction is expected to begin in September 2021.
